Solicitors - What You Need to Know

Maybe it is the nice weather, or perhaps a sign of healthy economic times – for whatever reason, it seems that we have been experiencing an increase in solicitors knocking on our doors. This is disturbing to many of us and the intrusion is not welcome. In the past 4 weeks, I have had offers to paint my home, coat my roof, fix my driveway cracks, and trim my trees.

These sales-people are trying to engage a homeowner who is vulnerable to their hard-sell tactics. Many use unfair methods such as:

- offering a special price because they have leftover materials and they can "cut you a deal" because they just finished another job and they are already in the area;
- perhaps the person may report some damage or problem on your house and he claims they are doing you a favor by letting you know – they are really using scare tactics on you.

Our community has "No Solicitation" signs posted at each entrance. Unfortunately, the City of Scottsdale told me that these signs may deter a few people, but the folks with bad intentions will ignore them – the signs are not enforceable – at best, they are a suggestion.

A homeowner can put a "No Solicitor" sign near their front door and an individual may be more likely to honor that – but not always. If a door-to-door sales person engages a homeowner, he must be licensed by the City of Scottsdale and must have that license on his person – not in a car or someplace else. However, the City issues very few licenses and consequently, most door-knockers are in violation of the law. If someone ignores your sign or is unable to show you a license, you may call the non-emergency police number (480-312-5000) – but this is not a high priority call and the pests may be gone by the time the police arrive.

The best alternative is to not answer the door to strangers — use a peep hole to see who is at your door. If you are not sure you want to open your door, you can shout through the closed door to find out who is knocking. Tell them you are not interested. If the solicitor persists, you might tell them to leave their literature at the door and you will ask your husband, brother, son or daughter to review it when they get off the phone — yes, that is a white lie but you give the impression you are not alone.

Another safety tip is that if you see the doorhangers/newspapers at the door of a neighbor and you know that that homeowner is out of town or away for a few days or more, you might remove the item for the neighbor. A pile up of door hangers that are left for a few days may allow would-be burglars to notice that no one is occupying the house.

But remember, if you feel threatened at any time, you should call the police emergency number – 911.



Thoughts on Travel: Booking That Dream Cruise





Decisions must be made, and it is surprising how many are necessary. What class cabin do you wish? Inside, outside with obstructed view, ocean view, balcony, etc? Where do you want to be on the ship? The mid-ship cabins on each deck will cost more than those forward or to the stern.

On many ships you must decide which seating you want in the dining room. Do you prefer to dine earlier or later in the evening? In each port your ship will offer a choice of several shore excursions usually of various lengths, costs, and physical difficulty. You may also make your own shore arrangements. The sooner you decide on these options the better your chances of obtaining your first choices. Check the dress code, too. Some cruises are country-club casual, others have formal nights requiring jackets for men and gowns for ladies.

What are your departure and arrival ports? How will you get to these places? Will the cruise line include the price of your airline tickets to and from, or will this be at additional expense? If you are leaving the U.S. on this cruise is your passport current and do you have at least six months remaining eligibility? Some countries may require a visa which your cruise line may assist you in obtaining, or you may need to apply on your own. There may be port charges in addition to the price of the cruise. Don't forget travel insurance. The cruise line may offer it or you may purchase your own. Medicare does not pay for medical expenses incurred outside the U.S.

RECIPE OF THE MONTH -

I am sharing another recipe from Lori Barnes. It's very easy and yummy!

ROAST LOIN OF PORK WITH SHAKER-STYLE VENISON SAUCE

4-5 pound boneless pork loin roast

red wine

Shaker-style Venison Sauce (see below)

Venison Sauce

1-cup drippings, grease removed

1-cup brown sugar

2 oz blackberry brandy (optional)

1 cup Currant Jelly

¼ cup Dijon mustard

Combine sauce ingredients in a saucepan. Simmer 5-10 minutes.

Method of Preparation:

Place the pork in a roasting pan, and season with salt and pepper. Sear in a 450 F oven for 20-30 minutes. Add red wine to depth of half an inch in the bottom of the roasting pan. Cover the pan with foil. Cook in a 400 F oven. 30 minutes to the pound. Reserve pan drippings for the sauce. Thinly slice the roast, and serve with the shaker style venison sauce.

Architecture Standards Committee Policies and Practices

The following policies and practices have been established by the Architecture Committee per Article VI of the 2004 Declaration of Covenants, Conditions, Reservations and Restrictions for the Golden Keys Subdivision. These policies and practices, or modifications to them as approved by the Architecture Committee at some future date, will be distributed to all members prior to being considered current.

Backyard privacy wall modification:

Residents who wish to cover the decorative course of blocks in a shared party wall or a back, side or front wall are permitted to do so if done in accordance with the following procedure. Prior to modifying the wall, residents must submit a written request to the Architectural Standards Committee. If the wall is a party wall, written Neighbor Comment Forms must be submitted with the request. The Neighbor Comment Forms provide the opportunity for the neighbor sharing the wall to express any opinions or concerns - for example: painting the back of material used to cover the decorative block such that it matches the impacted neighbor's wall color; using adhesive that results in a finished construction appearance from the impacted neighbor's side of the wall. If the wall being modified is not a party wall the changes must be done so that a finished construction appearance is maintained from the outside of that resident's property and the back of any material visible from the outside of the wall is to be painted to match the side of the wall from which it is visible.

Backyard or side yard building/structure installation:

Residents who wish to construct or modify a building or other structure in their back or side yard must submit a written request to the Architectural Standards Committee. If that structure will be higher than the height of the wall neighbor comments should be solicited from all neighbors that have line of sight visibility of the building or structure from their property. Neighbor Comment forms are obtained from the Architecture Standards committee. They are also available in the Clubhouse file and are included in the initial packet members will be provided after (date this is finalized) 2017.

Color Palette:

Approved colors are the Benjamin Moore exterior paint colors listed below. Members wishing to change the color of their house must pick from this palette. Any home may be repainted to match the color of that house as a normal maintenance activity. The AC should be notified prior to performing any maintenance activity on the exterior of the home or alley wall, including re-painting. Note that members whose houses were not one of the colors from the approved palette at the time the palette was approved are not required to modify the color or their house when that house is repainted. If an owner does wish to modify the base or trim color of their house they must select colors from this palette. Members can view samples of each of the colors by contacting the Architecture Committee paint palette coordinator. Your Parapet walls (Firewalls) must be painted the same color as the base color of your home when repainting.

Proposed - Director Expense Reimbursement Policy

Directors serving on the Board of a community association have very specific fiduciary responsibilities set forth by Arizona Law. This Director Expense Reimbursement Policy (Policy) is written to help provide guidance on reimbursement of expenses incurred by Board members while carrying out their responsibilities.

Arizona Law is clear that Board members can neither receive income nor directly and personally profit from their work serving the community. There are very few, and specific, exceptions to this guidance. These exceptions are not addressed within this Policy document.

- 1. Travel Expense the following expenses will not be reimbursed to any Director while performing duties as a Board member of the Association.
 - a. Reimbursement for mileage or commercial travel (airplanes, buses, hired car service, etc.).
 - b. Lodging.
 - c. Meals, whether related to travel, seminar attendance, or any other reason unless explicitly approved by a majority vote of the Board of Directors.
- 2. Computers Hardware, Software, and network access
 - a. Computer equipment, printers, scanners, miscellaneous devices.
 - i. Reimbursement for any hardware expense must be approved by the Board of Directors in advance and must show a clear business justification. Any hardware must be licensed to the Association and, if a peripheral device, may only be connected to an Association computer. The equipment must be solely for the use of the Association and must be available for use by any member of the Board. For reference, computer hardware is the physical parts or components of a computer, such as monitor, keyboard, computer data storage, hard disk drive (HDD), graphic card, sound card, memory (RAM), motherboard, and so on, all of which are tangible physical objects.

b. Computer Software

- i. Reimbursement for any computer software expense must be approved by the Board of Directors in advance and must show a clear business justification. The software must be licensed to the Association and may be only installed on Association-owned hardware. The equipment must be solely for the use of the Association and must be available for use by any member of the Board.
- c. Expense for Internet access is the personal responsibility of each Director and will not be reimbursed
- 3. Supplies and miscellaneous expenses
 - a. Office and computer supplies
 - It is reasonable that the actual cost for office supplies be reimbursed as necessary for a Director performing assigned duties. These supplies may include binders, file folders, labels, postage, envelopes, paper, etc. These items must be

- solely for the use of Association business. Items such as staplers, tape dispensers, paper clips, etc. are difficult to separate from personal and Association business and in most cases, will not be approved.
- ii. Consumable supplies used by computers that are owned by the Association can be reimbursed. Computer supplies most commonly used included, paper, ink/toner, paper, envelopes, and labels.
- iii. Purchases of Computer supplies for use on or with personally own computers will not be reimbursed. Computer supplies include laser cartridges, printer toner, etc.

4. Photocopies

- a. Copying expenses for association business will be reimbursed when performed by commercial businesses (such as Copyworks or Kinko's).
- b. The Association will not reimburse (on a "per sheet" basis) for copies made by an individual/personally-owned copier, computer printer, etc.

5. Other expenses

a. Directors may pay directly for products or services necessary for Association business. Whenever possible, payment should be made by an Association check issued by the Treasurer. If obtaining a check is not practical, a Director may personally pay for the product/service and submit the expense for reimbursement. As a general guideline, expenses above \$500.00 should be paid by Association check.
