## **Ground Beef and Cabbage Skillet**

1 lb ground beef

1 onion, chopped

½ head cabbage, chopped

1 15oz. can diced tomatoes

10 oz. can tomato sauce

Cooking fat (olive oil, coconut oil, etc.) your preference





### **PLASTIC CONTAINERS**

All plastic cups and containers #1-7, plastic bottles, jugs, jars, yogurt containers, cottage cheese containers, margarine and whipped topping tubs, plastic "Clamshell" food containers and disposable plastic cups. (No plastic liners, and No plastic bags.)



### PAPER

Computer and writing paper, file folders, window envelopes, paper grocery bags and junk mail. (No facial or toilet tissue, paper towels, napkins, diapers, self-sealing or FedEx envelopes or dog food bags.)



### CARDBOARD AND CHIPBOARD

Dry food boxes such as cereal, cake mix and cracker containers (please remove liner) shoe boxes, pizza boxes, empty paper towel and toilet tissue tubes. (No bar soap or detergent boxes.)



**GLASS** 

Food and beverage containers. (No light bulbs, pottery/ceramics or window glass.)



**NEWSPAPERS** 

Include all inserts.



**ASEPTIC BOXES** 

Milk, juice and ice cream containers.



**ALUMINUM & FOIL** 

Beverage cans, aluminum foil, clean frozen dinner trays, pie plates, and food containers.



METAL

All metal food cans and empty aerosol cans. (No paint or toxic materials.)



### **All MAGAZINES & TELEPHONE BOOKS**

(No hardbound books.)



- All material must be clean, dry and empty
- No grass, yard or food waste
- No plastic bags \*with the exception of clear plastic bags that contain shredded paper
- Please have your recycling container out by 5 a.m. on the day of collection
- Bag all loose papers in brown paper bags to avoid blowing papers

- 1. Bank accounts are balanced as of month-ending August 2018
  - a. Also balanced for the months ending June and July 2018
  - b. Taxes were paid to IRS in the amount of \$454.00 (current tax bill, no penalties). Thank you to Bob Will for reviewing the forms prior to submission.

### **Deposit Analysis Summary**

No specific deposit was made to the Reserve Account for F/Y ending April 30, 2018. Note the following:

- 1. Budgeted deposit for F/Y was \$14,950.00.
- Actual amount spent during F/Y for reserve-related expenses was \$17,854.69
- 3. All reserve-related expenses were paid from the operating fund account (BofA checking) and it was not necessary to withdraw funds from reserve-designated accounts (i.e. Vanguard)
  - a. By retaining the budgeted reserve contribution in the operating fund account, this essentially "repays" that account for the bulk of the amount used for reserve spending.
  - b. The excess spend of \$2,904.69 was paid by the operating fund
