#### **OPERATING BUDGET of YOUR HOA**

Earlier this month, your Board of Directors met to develop the Association budget for fiscal year 2019-2020. Just like your own personal budget, the process is not an exact science. We can never predict what might break, when vendors may have price increases, and numerous other variables. We do have our past financial reports to help guide us as well as the knowledge and experience your Board members have gained during their tenure.

At its February meeting, the Board approved the proposed Operating Budget for FY2019-2020. <u>Based on that budget, the homeowner assessment will remain at \$700.00 per member</u>. This is the result of the cost-conscious efforts of the Board and Committee Chairpersons plus extra income that will be realized through property transfer fees collected when a home sells in the Community and an investment strategy depositing our reserve funds in higher-paying, FDIC insured accounts.

Our Community is aging and there are going to be important, and sometimes expensive repair and replacement items required of our landscape and physical assets. These costs are not part of our routine operating budget. Our Association reserves are well-funded to cover these anticipated capital expenditures.

Based on the budget, this is a brief recap of where your annual assessment is spent:

Administrative Expenses:	\$78.74
Clubhouse Expenses:	\$28.36
Landscaping Expenses:	\$212.91
Pool Expenses:	\$119.65
Real Estate Expenses:	\$0.52
Utility Expenses:	\$146.91
Insurance Expenses:	\$17.70
Reserve Contribution:	\$95.21

During discussion an amendment was made and seconded to revise the last sentence to read, 'The limitation will be valid through the October, 2019 GK Board Meeting.' Amendment seconded, approved unanimously.
