Smoked Sausage Jambalava From The Southern Living Cookbook

One pound of smoked sausage cut into ½ inch slices.

One pound ground beef

½ teaspoon of cajun seasoning

Treasurer's Office and Finance Committee Report - prepared by Tom Kernen

February 21, 2023

- 1) Bank accounts are balanced for February 2022.
 - a) Monthly reports distributed to all Directors for review on March 2.
 - b) All invoices received through March 20, 2023 are paid in full.
- 2) The HOA received an unusually large records request from a member which has resulted in a large volume of printing/copying. Fulfillment of this request will result in 15-20 hours of volunteer board member time, approximately 800-900 copied pages, and the hiring of 2 "gig workers" to assist with the copying of the requested documents. The cost of the copies is born by the requestor. The cost of the 2 workers will be paid by the association from all members' annual assessments.

The Arizona Planned Communities Act allows members to make reasonable requests for records. Requests can result in allowing the requesting member to review, in-person, specific records or for copies to made and given to the member – at a cost of \$0.15 per page.

The Association receives requests throughout the year and are typically not as broad in scope as the most current request.

3) Invoices for the annual assessment will be hand-delivered and mailed to all members on April 1.

Obtained an additional bid for Backflow testing. In process of obtaining new bid from current vendor.

Working with AZMetro on feeding and fertilizing Oak and Sumacs. Cost is \$785.00 for all. I am waiting to hear if this will take care of the apparent yellowing of some of the leaves of the oak trees.

Irrigation of dormant lawn will resume in April along with mowing and we will no longer have the discount from AZMetro.

One of the sumacs along the west wall of the common area was severely damaged during the storm on February 23 and AZMetro took care of the damaged branches. This means one less sumac for the tree trimmers in June.

Community Liaison Committee Report

I found another leak in the canal east of Golden Keys. I provided details to SRP. No word on when they will clear out debris on other side of wall along 63rd Place.
